WHY DO WE USE COOKIES?

Please note that withholding your consent does not automatically delete any cookies that are already on your device pursuant to your previous consent. You will need to delete these cookies manually. Privacy Policy LE&O

WHO IS RESPONSIBLE FOR YOUR DATA?

WHAT INFORMATION DO WE COLLECT AND WHY?

WHO HAS ACCESS TO YOUR PERSONAL DATA?

Your personal data is accessed by our employees to the extent necessary to provide you with the services you have requested. Except for our website provider who assist us with the administration of our website, we do not share your personal data with third-party service providers. In addition, we may share your data with public authorities or other entities as required by law.

HOW LONG DO WE RETAIN YOUR PERSONAL DATA?

We retain your personal data for as long as necessary to provide you with the services you have requested. If you have not interacted with us for a consecutive period of two years, we will only retain specific data that we are required to keep by law or to protect our legal rights.



DO WE TRANSFER YOUR DATA OUTSIDE OF THE EEA?
